Did you know that Executive Order 13513 “prohibits text messaging and emailing while driving during official Federal Grant business”. Simply put “ADRS employees are prohibited from text messaging while driving a government-owned vehicle or while driving their own privately-owned vehicle during official business or from using government-supplied electronic equipment to text message or email when driving”. This prohibition also extends to ALL individuals and organizations that have Contracts and/or Agreements with ADRS. Contractor’s must agree to prohibit their personnel from text messaging while driving a government-owned vehicle or while driving their own privately-owned vehicle during official business or from using government-supplied electronic equipment to text message or email when driving.

Congratulations to Mississippi State University’s Rehabilitation, Research and Training Center on Blindness and Low Vision

Winner of the highly competitive five-year, \$4.25-million federal grant will allow a Mississippi State center to initiate and expand research into systems change, education, training and outreach activities that foster employment of people who are blind or visually impaired.

The University Center will receive \$850,000 this year and annually through 2015 from the National Institute on Disability and Rehabilitation Research. The funding will support the center's efforts to increase competitive opportunities and outcomes for blind or visually impaired individuals in the job market. I Memoriam Vera J. McClain

Vera J. McClain died in January 2010, after several years of declining health and a career of working for the blind and visually impaired. Born in Cullman, Alabama, in 1927, she lost her sight to glaucoma. She learned blindness skills at the Alabama Training Center for the Deaf Blind in Talladega, AL. She went on to earn a BA in social work from Montevallo University, and her MA in Rehabilitation at Hunter College in New York. Ms. McClain spent 17 years working for the Alabama State Rehabilitation Agency, where she built a national reputation, and then moved to the Florida State University in 1972, where she taught Braille and communications skills to future blindness professionals. In 1982, she returned to Alabama as a Rehabilitation Teacher, retiring in 1995. During her life, she was an avid supporter of ACB, writing articles for "Braille Forum" and advocating on behalf of the blind. In retirement, she also joined the Silver-Haired Legislature, a group that lobbied the Alabama state legislature on behalf of senior citizens.
